

**Redbud Run Elementary School  
Parent Involvement Policy  
2017-2018**

Redbud Run Elementary School jointly developed this parental involvement policy in consultation with school personnel, community members, and parents and adopted it on *August 29, 2017*. Redbud Run Elementary School will:

- (1) Convene an annual meeting on August 28 and August 29, 2017 to which all parents shall be invited and encouraged to attend, to inform parents of their school's participation in Schoolwide Title I and to explain the requirements of Title I, and the right of the parents to be involved;
- (2) Offer a flexible number of meetings. A schedule of this year's meetings will be announced in school newsletters;

Redbud Run Elementary School will:

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
2. Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a convenient time to parents, and will offer a flexible number of additional parental involvement

meetings, so that as many parents as possible are able to attend. The school will invite to this meeting all parents, and will encourage them to attend.

**Part 3. BUILDING CAPACITY FOR INVOLVEMENT**
